### **COMMITTEE REPORTS:**

<u>Public Safety:</u> Mr. Nolan wanted to thank the Borough Police Department, Fire Department and First Aid for the success of the tree lightening ceremony. He also thanked Chief Blewett for the noticeable decrease in problems along Bay Avenue and within the Borough regarding problems with the youth.

Chief Blewett added that based on recommendations from the Superior Court, the Police Department and the Municipal Court had implemented new security measures in November in order to provide a secure atmosphere for court personnel as well as persons attending the court. Anyone entering the court will first be stopped at an access station and checked for prohibited items and use of a handheld metal detector is employed.

When court is in session, the rear of the building is locked and access is denied except for disabled persons. The Court Administrator has reported that court sessions have been orderly and efficient because of these measures.

Chief Blewett also stated that the first town meeting was held on November 13<sup>th</sup> at Henry Hudson Regional. This meeting focused on gangs, school violence as well as school issues in general. The New Jersey Gang Investigators Association/Prevention First, the Monmouth County Prosecutor's Office and the Highlands Police Department gave presentations.

Mayor O'Neil asked Chief Blewett what the approximate age of the Explorers are.

Chief Blewett stated that participants are required to have graduated from the 8<sup>th</sup> grade and can be up to 20 years old.

Chief Blewett said that he has been working closely with Mr. Braswell on the police department website. The website should be completed and accessible within the next few weeks. The police department website can be accessed directly off the main page of the Borough website.

Mayor O'Neil stated that he had spoken with Chief Blewett recently with regard to the skate park as far as getting a lock for the gate and monitoring the area, i.e. children without helmets, locking up after hours., etc.

**Parks and Recreation:** Nancy Thomas said that the Community Center is nearly complete. The kitchen appliances have been ordered and are anticipated to be installed by the end of January. Ms. Thomas thanked the Genevive Hawley Foundation for their donation of the window blinds for all of the windows in the Community Center.

Ms. Thomas talked about upcoming programs such as, Breakfast with Santa on Saturday, December 16<sup>th</sup> from 9 to 11 a.m. Girls' basketball, grades 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup>, Tuesday afternoons starting on January 9<sup>th</sup> at Highlands Elementary School and boys' basketball, grades, 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> on Thursday afternoons. There will be an open gym held at Highlands Elementary School, dates are yet to be determined. Also, an adult indoor soccer league Monday evenings at the high school for 35 years old and up. The senior citizens' programs are every Thursday, January to December, 2007. And also there will be an afternoon program at the elementary school for 2<sup>nd</sup> and 3<sup>rd</sup> grades on Tuesday afternoons. Tim Hill and other people from the Recreation Department will be teaching games, basketball, etc.

Ms. Thomas stated that there are a number of pending programs for the Borough such as, basketball shooting clinic, an after school program for 2<sup>nd</sup> through 6<sup>th</sup> grades and also a teen program. She also stated that the Pony Program will go forward for 2007. And finally, a Mad Science program for students interested in science.

Ms. Thomas thanked the DPW and the Highlands Business Partnership for spearheading some electrical problems in the Borough to make the tree lighting a success. She also thanked the DPW for putting all the trash cans out as well.

**HBP:** Mrs. Braswell expressed her appreciation to all who helped out with the tree lighting ceremony, such as Tim Hill, Ms. Thomas, the Police Department and the Fire Department. She stated that they are in the process of putting a committee together to build a sleigh for next years' event. Ms. Braswell stated that they have submitted their calendar of events for the year 2007, and once approved, will be posted and they will be moving forward.

Mayor O'Neil asked Ms. Braswell, within the Borough of Highlands, how many clam fests, tree lighting ceremonies St. Patrick Day parades and Octoberfests have there been.

Mrs. Braswell stated that there have been 12 clam fests, 11 tree lighting ceremonies, 5 St. Patrick Day parades and 6 Octoberfests. She also stated that the Twin Lights Bike Ride has gone on for 5 years.

Mrs. Braswell spoke about correspondence received from Councilman Caizza dated November 29<sup>th</sup>, with questions several items. Mrs. Braswell read the following into the record:

Dear Mrs. Ceflo-Braswell;

I have been asked a few questions recently that I am not sure of the answer to and I would like to clarify my answers rather than give out incorrect information.

First, would you please tell me the name of the Secretary for the Highlands Business Partnership (HBP)?

Second, I have been asked about the \$20,000.00 budget item for salary. Can you tell me to whom this salary is paid?

Third, Ken and Kathaleen Shaw have been seen working on the electrical components at the sign on the Highway. Please see to it that only a licensed electrician works on these items?

I would like to hear from you as soon as possible, I do not think the answers to the first two items require a lot of thought and I am sure you will take care of the third item as soon as possible.

Mrs. Braswell then read into the record, her response:

Dear Councilman Caizza:

In response to your November 29, 2006 letter to HBP, we hope to clarify your questions.

First, the name of the HBP Secretary is Eddy Sousa, who serves as one of the officers of the corporation. Eddy Sousa also chairs the marketing committee.

Second, the budget line item of \$20,000 for HBP Administration in the 2006 budget is utilized for part-time management services that handle the day-to-day operations of the business improvement district. HBP is using the professional services of Downtown Network Co., Kathaleen Shaw, since August 2006 after LoriAnn Bodnar-Nolan resigned for personal and health related issues.

Third, Ken Braswell and Kathaleen Shaw were changing light bulbs and checking the timers on the highway/bulkhead sign. The actual repairs to the lights on highway/bulkhead sign were made by GEO electric on 7/17/06 (invoice attached).

Lastly, with Mayor O'Neil's verbal approval, Ken Braswell and Kathaleen Shaw, on behalf of HBP, completed an inventory of the condition of the public area lighting in Huddy Park, in anticipation of the December Holiday Lighting Event. The electric panel clock timer's settings for the various locations were checked in order to start the lighting repair process. The repairs were discussed with the Borough Officials and completed by a licensed electrician on 11/30/06 in the amount of \$1530.00 paid by the HBP (invoice attached). The boro purchased the materials for approximately \$300. No permit was required as they were simple repairs of ballasts, switches and plugs. In moving forward, the light bulbs must be maintained by the borough in a timely manner to avoid last minute costly repairs. Without these last minute repairs, there would have been no tree lighting.

Lighting in several public areas are still in disrepair. A detailed plan is being worked on by the HBP VIC Committee, which will be presented to the Borough. Thank you for your cooperation.

Mrs. Braswell also stated that originally Soden Electric was called, but could not be there in time for the tree lighting, so M Tech was called out on an emergency basis. Originally the Borough was going to pay close to \$700 for the materials, so the Borough will be receiving a credit.

### **OTHER BUSINESS:**

### **Engineer's Report**

Robert Bucco, P.E. of T & M Associates stated the following:

- 1. Community Center Improvements Councilwoman Thomas gave the report on this item.
- 2. Community Center Playground/Sports Courts Improvements met with Tim Hill on November 27<sup>th</sup> to make sure that everything he wanted was on the plans. The plans are being finalized and should be completed within the next couple weeks.
- 3. Fire House Mayor O'Neil will be sending a letter out regarding the progress of the firehouse.
- 4. NJDOT Route 36 Bridge project is ongoing and we are reviewing some temporary sanitary sewer connections.
- 5. NJDEP Stormwater Management Regulations we are complying with all of the DEP regulations for the Tier A grant that Borough has received.
- 6. South Bay Avenue Pumpstation the electrical box had malfunctioned rather being struck by lightening and are waiting for EDC Electrical Contractors to provide a price to install a new electrical control panel.
- 7. Valley Street Emergency Sewer Repair currently negotiating with the contractor for a final price.

### Capital Improvement Projects

- 1. Valley Street Pumpstation Rehabilitation Project the pump should be in within the next few weeks.
- 2. 2006 Road Program need to schedule a special meeting to award the bid.
- 3. Basin Eight Sanitary Sewer Rehabilitation Project The project design is currently underway.

### **Grants and Loans**

- 1. NJDOT Application we received an additional \$148,000 for the Phase II of Washington Avenue, from Recreation Place to Marine Place.
- 2. Atlantic Highlands/Highlands Regional Sewerage Authority we have submitted a five year plan to the Authority and it is currently under review.

Mayor O'Neil asked about the letter that is going out about M&R Contracting regarding the firehouse, is that notifying their bonding agent that they are not performing?

Mr. Bucco stated that that is correct.

Mayor O'Neil asked how many days are they past the completion date.

Mr. Bucco stated that it was 75 days. He also stated that they were given an additional 166 days.

Mayor O'Neil stated that it is now time to either force the completion of the job or obtain another contractor to perform the work.

**Sanitation:** Mr. Urbanski stated that the Borough is in need of a garbage truck due to the problems with the current truck.

Mayor O'Neil asked what the price of a new truck would be and what is the lead time.

Mr. Urbanski stated that it would be 160K to 180K. The lead time would be approximately two months. Mr. Urbanski stated that the urgency would come around spring time when all the restaurants are busy and the truck continues to break down, the garbage can sits for too long.

Ms. Thomas suggested that there be a public auction for all the rundown material such as broken trucks, ambulances, etc.

Mr. Caizza offered a motion for the Borough to purchase a new garbage truck.

Mrs. Braswell stated that a budget would be submitted in January. Usually they rely on sponsors, donations and other fees to support the events.

Mr. Urbanski asked what last year's budget amount was for events.

Mrs. Braswell stated that she believed it to be \$20,000 for marketing and communications and \$35,000 for special events committee. She stated that they usually break even for the Octoberfest and the St. Patrick's Day Parade, for other events, there are sponsorship donations and vendor fees.

### **PUBLIC PORTION:**

Chris Francy - 36 5<sup>th</sup> Street - with regard to the firehouse, Mr. Francy questioned the approval of an invoice for \$111,000.00 and where it stands with the total budget.

He asked what the liquidated damages per day were.

Mayor O'Neil stated that they were \$300 per day. He also stated that the job is not on time or on budget.

Mr. Manco stated that the first step is to notify the contractor. If they don't comply or meet the next 50 days, Mr. Manco recommends to the Borough that they notify the bonding company that the contractor is in breech of his contract.

Mr. Francy asked how many weeks for the Valley Street Pump.

Mr. Manco stated that it will be two to three weeks, and that the contractor will install it as soon as it comes in.

Mr. Francy wanted to know what the status was of the South Bay pump - was it not working, or what is the problem, because there has been quite a bit of backup problems.

Mayor O'Neil stated that that is sanitary sewer not storm water.

Mr. Francy also asked which garbage truck was failing.

Mr. Urbanski stated that one of the yellow trucks continuously breaks down, since it was new, approximately 2001.

Joe Soden - President, Highlands on the Bay - inquired about the status of the town punch list.

Mr. Manco stated that that was an item discussed in Executive Session and not yet resolved. Once a recommendation is made to the Mayor and Council and then a decision, it will be made public.

Mayor O'Neil asked Mr. Manco to explain for those who are not familiar with the process.

Mr. Manco stated that under the Open Public Meetings Act, there are a number of things that can be discussed in Executive Session (closed session) and not released to the public. Some of those things pertain to pending litigation, anticipated litigation or contract negotiations. He went on to say that when discussing options involving performance bonds and whether the Borough will take action or not, there are strategies that are being formulated that would not be in the Borough's best interest to disclose.

Mr. Soden asked if there was an estimate as to when the public will hear something.

Mrs. Flannery stated that there should be something at the next meeting which is scheduled for December 20<sup>th</sup>.

Mr. Manco stated that there is a plan formulated that will be discussed with the Mayor and Council.

Mr. Soden asked about the process for public grant money regarding beach erosion and dock repair. He also asked if the Borough has any history for this process and in dealing with the engineers regarding same.

stated that he can make inquiries with the Army Corps of Engineers to find out schedules, grant monies available, etc. He stated that the Borough has no history with regard to obtaining grant money, but that we are in line for that as well as other towns regarding beach erosion.

Mr. Soden asked, what are the next steps that should be taken in order to facilitate that process.

\_\_\_\_\_ stated that sending letters would be helpful, that it is best that they hear from the public and people who are directly affected by beach erosion.

Mrs. Flannery suggested that if anyone wishes to have the name of a contact person, to please call her office and she will get that information to them.

Ellen Olverson - 220 Marina Drive - President, Bay Pointe Condo Association - First, she would like to know that if there is over \$1 million in surplus, why is the Borough raising the taxes?

Mr. Pfeffer stated that budgeted surplus is revenue source, like interest on investments, and other fees and permits come back into the budget every year, and so the million dollars that are in surplus, we have that every year, it's a recurring number.

Ms. Olverson asked if the Borough always has a million dollars in surplus.

Mr. Pfeffer said that not always, and that the Borough has had a major turnaround financially in the last five years.

Mayor O'Neil stated that at the time he was elected mayor, the Borough was approximately \$750,000 in the hole.

Ms. Olverson then asked why the Borough was raising the taxes if there is a million dollars in surplus.

Mr. Pfeffer stated that there was not enough in surplus to prevent a raise in taxes. Every year there is a budget process and the needs of all the departments is determined on the spending side of the budget and there is also the revenue side of the budget and the million dollar surplus is just another piece of revenue, and there is not enough to offset all the expenses to break even.

Ms. Olverson then asked, in light of that, is it possible to have Shore drive paved?

Mayor O'Neil stated that what the Borough does with the Road Program is go out and look at all the roads, and he acknowledges that some of Shore Drive is in rough shape but that it is not in as rough shape as some other roads.

Ms. Olverson stated that cars for the ferry go down her road, sometimes at 40 mph, there are potholes everywhere, and she would like to please get the road paved.

Mayor O'Neil said that it would not be for awhile.

Mrs. Olverson then asked if she could get a street sign at the end of her road so as people know what the name of the road is.

Mayor O'Neil agreed that that could be done. He then stated that he could have the Borough go out and patch the road for the time being.

Ms. Olverson then asked the Mayor if it was possible that after the Borough unloads the recycling bins in her complex, if they could please put them back inside.

Mayor O'Neil stated that they should be putting them back, and that it will be done.

Ms. Olverson asked the Mayor if whenever there is a reason why the bins do not get picked up, such as other garbage that does not belong in there, could their department state the reason why and not just leave a note saying that it could be any one of three reasons.

Ed O'Neil - 286 Bay Avenue - stated that the one of the reasons that Shore Drive is such a mess is due to the outfall running through. He suggested that the Sewerage Authority (Highlands and Atlantic Highlands) come down and mill the center of the road.

Fred Kayless - Portland Road - wanted to let the Mayor and Council know that last night, the Mayor and Council of the Borough of Sea Bright voted unanimously to withdraw their support of the demolition of the Highlands Bridge. He stated that the reason was that the Historical Council of the DEP voted unanimously in October to recommend that the Commission deny the application to demolish the bridge. He wanted to know if it was the intent of the Borough of Highlands to do the same.

Mayor O'Neil stated that it was the intent of the Borough of Highlands to discuss it and have it on the agenda for the next meeting. He asked the audience if there was anyone else who had comments regarding this issue.

Donna Callahan - 29 S. Bay Avenue - stated that she became involved with this process nine years ago, and she recalls being told that she had no choice, that the bridge needed to be replaced, repair was never an option given to her.

Mayor O'Neil stated that it was always stated that the bridge had to come down and that it was unsafe, repair was never an option.

Ms. Callahan then stated that she received a letter from the Preservation Council in Trenton regarding a meeting that she could not attend, but later, with a group of people, attended a second meeting. She was told that NJDOT basically lied to the town regarding the bridge. Originally the DOT stated that the bridge was unsafe and that she watched a presentation stating that the Highlands Bridge is one of the safest bridges in the State. Ms. Callahan stated that she has since written letters to the Governor, to the Preservation Committee. She is here tonight because she feels that the people of Highlands have been done an injustice. She then asked, if the DOT is going to put up this new bridge, to move traffic faster, where is the traffic going?

Mayor O'Neil stated that having a new bridge in no way would alleviate the traffic problems within the Borough of Highlands.

Ms. Callahan suggested that the Mayor and Council support repairing the bridge.

Jim Carton - Portland Road - he believes that one way to alleviate traffic problems would be to open the bridge on the hour as opposed to on the half hour. He believes that approximately 3 percent of all the boats that go under the bridge require that the bridge be open. He also suggested that perhaps patrons of Sandy Hook pay as they leave the park as opposed to paying as they enter the park to minimize the traffic congestion. He believes that with a new bridge, roughly 30 feet higher than it is now, would impact not only his view, and that of the residents on Portland Road, but more importantly, decrease the value of his property by almost 50%, which would then decrease the taxes to the Borough.

Steve Selecki - Highland Avenue - concerned about the redirection of traffic during the bridge construction or repair onto Highland Avenue and the impact that would have on sewer lines, residents, kids, etc.

Mayor O'Neil stated that there has been several ideas regarding the bridge and the impact construction and/or repair will have on the community. He appreciates people coming out to express their feelings regarding this matter.

Maureen Kraemer - she would like to know where the Borough stands with regard to the construction or repair of the Highlands Bridge. She also stated that recently she spoke to Mrs. Flannery and inquired about when there was going to be a meeting on this matter, and she was told that the Steering Committee would be holding a meeting on the 15<sup>th</sup> - the Borough of Highlands does not seem to be proactive regarding the bridge - where is Mrs. Little regarding this - is she not on the Steering Committee - at the council meeting in Sea Bright, Ms. Kraemer got the impression that they see the need to get the information out to the appropriate people, such as the Governor, the Assemblymen, Senators, etc.

Mayor O'Neil stated that indeed they are interested in what the people think, in fact, he asked for input.

Ms. Kraemer stated that there is great concern on her part regarding the lack of interest from the Borough of Highlands. She is concerned with the impact on the Borough regarding the rerouting of traffic, especially during the months of July and August (Saturday and Sunday).

Chief Blewett spoke regarding traffic and stated that there was a meeting, and he has repeatedly requested more meetings, especially regarding traffic being rerouted onto Highland Avenue.

Ms. Kraemer reiterated her statement from the last meeting regarding the Middletown/Red Bank Bridge, and how the only way they were able to get anywhere with the State was to involve, at that time, Steve Kryllios. She also asked Mrs. Flannery when the minutes she requested would be ready.

Mrs. Flannery stated that they are not typed yet, and that they are working on the August meetings and she did not have a timeframe for Ms. Kraemer when the minutes would be ready.

Carla Braswell - 62 Gravely Point Road - she stated that when she first started attending meetings with regard to the bridge in 2000, there were key administrators on the committees that reported back to the Mayor and Council at their council meetings. She feels that the Borough of Highlands should not be relying on volunteers to report back and they should have a representative from the Borough to attend all the meetings and report back to the Mayor and Council. She feels that if this had been done all along, the residents would have been informed all along.

Tim Hill - Director of Recreation/Borough of Highlands - wanted to bring to the attention of the Mayor and Council that he has been informed that there is full permit to move forward with this project. That does not mean that the project is yet moving forward. He also stated that there is in fact a meeting on the 15<sup>th</sup> that is not opened to the public. At that time, there will be a public information center setup, which has been requested.

Chief Blewett stated that he received an e-mail from Fred Kayless with regard to this matter and he has gained a lot of information from Mr. Kayless.

Mr. Kayless stated that he went to meetings and listened to the DOT and the DEP and heard all the arguments.

Chief Blewett told Mr. Kayless that he did read his e-mail and that he did prepare a response that he will send to him.

Spencer Adler, Esq. - his sister lives in Highlands and had asked for help regarding the bridge and he went to a meeting in Trenton to gather information. He feels that there is no one person to blame for all the misinformation - except for one exception - that if the DOT comes into Highlands, with all their consultants, and says one thing, and then goes to Trenton and says just the opposite, there is no wonder that people are pointing in all different directions. People may stop going to meetings and asking the hard questions when they believe that there is really no choice but to replace the bridge.

Mr. Adler stated that he had attended a hearing in Trenton on August 19<sup>th</sup>, and one of the disturbing things was that the DOT, not knowing that there may have been Highlands residents there, was asked by the Historical Sites Council (after hearing all the testimony) why the bridge has to be torn down. The DOT stated that the local people were demanding it. The Council asked the DOT if the residents of Highlands knew that there were alternatives to tearing down the bridge. The DOT stated that there were five alternatives and tearing down the bridge was the one that they wanted. Highlands does not want to do a repair, they do not want to do a replacement with a similar drawbridge. They really just want to do a fixed bridge because they are really upset about the traffic.

Mr. Adler stated that there were four people at this meeting whose main concern is the Borough of Highlands, himself, his sister, Mr. \_\_\_\_\_ and Fred. Kayless. When the time came for public comments, they stood up - the DOT was not prepared for all the questions that were coming at them, from the Historical Sites Council, and the head of the team for the DOT stood up and said, "On behalf of the State of New Jersey, we are withdrawing this application pending further review."

Mr. Adler then said that the DOT came to another meeting two months later and said just the opposite, well, maybe none of the locals want it, but the bridge is falling down, here are some pictures. The Historical Sites Council stated that they know what structures are supposed to look like and how they age, that is their business. That their pictures show that the bridge was not maintained properly for the past 10 years or so. The DOT stated that the bridge, even if it is fixed, will not be earthquake proof.

He stated that one of the things that angered the Historical Sites Council most, was the question of safety. The DOT had stated that the bridge is very unsafe for motorists and that it is not up to code. The Historical Sites Council asked the DOT for the numbers, such as, what are the accident rates on this bridge. The DOT answered that the accident rates are actually half of what they are on comparable bridges in the State. The Council responded that the DOT is then suggesting that they replace one of the safer bridges in the State with one that is more than twice as high and may be very steep and exposed to all kinds of weather conditions.

Mr. Adler stated that previously he mentioned one exception - that there was one woman who consistently rolled her eyes at meetings and the like - and that at one meeting he asked her for her business card - thinking she represented the DOT - and he was handed a business card from Jacobs Engineering - one of the worlds largest heavy construction firms. Mr. Adler stated that as a lawyer, he thinks, fraudulent inducement - that the residents of Highlands have been told something in order to get them to "sign on the dotted line". However, if they were fraudulently induced to agree, that they have every right to step up to the plate, file an injunction to rescind the documents that they were fraudulently induced to sign.

He went to say to Mayor O'Neil to look no further than his comment on this issue, "That's exactly what's always been told to us - that the bridge has to come down because it is unsafe." The fact that the mayor is, and always has been, under that impression -

Mayor O'Neil stated that he thought it was unsafe structurally, not because of traffic problems.

Mr. Adler stated that the Historical Sites Council say that anything can be repaired. He said, as an example, there is a bridge similar to the Highlands Bridge, in St. Augustine, Florida, 75 years old, there was an effort down there to replace the bridge, and the people got organized and demanded a repair. And now they will have a temporary drawbridge built along side the existing bridge during the repair of the old bridge. They have a web site called Thebridgeoflions.org. The total cost for that bridge, including the temporary bridge, is \$76 million. On the DOT web site it states that the cost for the replacement of the Highlands Bridge is approximately \$137 million.

Mayor O'Neil asked if that was just the construction or does it also include all of the money put into over the past 10 years.

Mr. Adler stated that it was his understanding that what is spent so far is under \$10 million

Chris Francy - was unclear about what Mr. Hill meant earlier, does he mean that the DOT has acknowledge that the Historical Sites was not supportive of the bridge application and that the DOT was overriding that - is that correct?

Tim Hill stated that no, they are not overriding it, and that it went to the commissioner's of DOT and DEP who oversee the state's Historic Sites Council and they have been told to move forward at this point.

Unidentified Person - does that mean that the DEP said yes to the DOT?

Mr. Hill stated that he will find out more at the December 15<sup>th</sup> meeting, but as he understands it, there is consideration of possibly an alternative construction.

Mr. Francy asked who was currently on the steering committee.

Maureen Kramer - 200 Portland Road - she would like to know if the Highlands Borough Council feels that this bridge is not a good idea it would be a good idea to align ourselves with Sea Bright because there is more power in numbers.

Mayor O'Neil stated that he had asked the Council should it be discussed now or put off to the next meeting.

Martin Kiely - 39 Shore Drive - the Mayor and Council are doing a really good job for the Borough, but having said that, he feels that the mayor was bamboozled by the DOT with regard to the bridge.

Mayor O'Neil stated that he was not bamboozled, but that he fully understood that the bride had to come down because it was a hazard.

Mr. Keiley said that that was his point, that the mayor was misinformed by state officials. Because of that misinformation, and what Mr. Adler said, on September 6<sup>th</sup> there was a meeting, was the Borough going to give a piece of property to the DOT.

Mayor O'Neil stated that they were going to trade off property.

Mr. Keiley asked if that was completed.

Mayor O'Neil stated that it was not.

Mr. Keiley asked if that was in the process of being completed.

Mayor O'Neil stated that it was still on the table because what they originally asked for, the Borough was not satisfied with.

Mr. Keiley asked - "Isn't that piece of land that's owned by the Borough an integral part of this entire process?"

He also stated given the information and the fact that the Mayor and Council were "misinformed", he is going to ask for a non-binding referendum tonight. He asked that the Mayor and Council let the residents know where they stand. He stated what better history for Highlands than the Highlands Bridge and the Twin Lights.

Mayor O'Neil stated that he would take a poll for a non-binding resolution tonight.

Ms. Thomas spoke about how she grew up in Highlands and that she is all for preserving the bridge, we all know that it has to be repaired. She feels that the Borough can make a commitment to work hard to get brought up to speed with what is going on and go through with the steering committee meeting on the 15<sup>th</sup>, and then on the 20<sup>th</sup> pass a resolution.

Mayor O'Neil stated that although that is a viable point, we are then two weeks behind.

Mr. Keiley stated, Sea Bright one day and Highlands the next, that is resounding to the State."

Matt O'Neil - 224 Navesink Avenue - sometimes at meetings when problems are brought up and discussed, and then come the next meeting, those same people are not in attendance. He stated that he too is for preserving the Highlands Bridge and the Twin Lights, and that if people do not show up at meetings, it falls to the governing body to carry the load. When everything is going good, no one is here, but when something goes wrong, everyone is at the meetings. To keep a fined tuned machine running, it needs constant maintenance, not just when something breaks. He stated that he is only 19 years old, he does not pay taxes to the Borough of Highlands, but he is concerned about preservation of the bridge. He feels that if everyone shows up at the meetings and voices their opinions and gives the governing body their support, that things will run smoother and more will get accomplished.

Jim Bodina - Highlands on the Bay - asked if the withdrawal of support from Sea Bright and then maybe from Highlands, is that going to stop this from moving forward?

Mr. Adler stated that his sister called him on a Tuesday about a hearing in Trenton that was being held on Thursday. At first he said he could not attend, but by Thursday morning he decided to attend the meeting. Since then, he has been at every important meeting, whether it is in Trenton or Highlands or Sea Bright. He feels that tonight is Highlands night. That the State is going to put the project out for bid by the end of the year and possibly award the contract in March. Then state that it is too late to change, it is already out for bid. All that matters is that the Governing Body was told that they had no choice, that the bridge had to be replaced. He feels that that is enough to step up and say that they are opposing this project. Mr. Adler suggested that the Governing Body take a vote tonight. He stated that Sea Bright put together a resolution based on what the Historic Sites Council said.

Mayor O'Neil offered the following Resolution and moved on its adoption:

### R-06-186 RESOLUTION

BOROUGH OF HIGHLANDS WITHDRAWING SUPPORT FOR THE DESTRUCTION OF THE HIGHLANDS TO SEA BRIGHT DRAW BRIDGE AND OPPOSING THE PROPOSED CONSTRUCTION OF THE FIXED SPAN BRIDGE

**WHEREAS**, the Mayor and Council of the Borough of Highland make this Resolution to advise the State of New Jersey and its Department of Transportation of the

Borough's opposition to any construction project involving the Highlands to Sea Bright Draw Bridge that would destroy and replace the historically significant bridge; and

**WHEREAS**, the Borough of Highlands agrees with the State of New Jersey and its office of Historic Preservation that there should be a commitment to enhancing the quality of life of the residents of New Jersey through the preservation and appreciation of our collective past by preserving historically significant structures; and

WHEREAS, it is the historic preservation office's mission to assist the residents of New Jersey in identifying, preserving, protecting and sustaining New Jersey's historic resources through the implementation of the State's Historic Preservation Program; and

WHEREAS, some of the historic structures in the immediate proximity of the Highlands Bridge include the Sandy Hook Lighthouse, the Twin Lights Lighthouse, Bahrs Marina which is a historical site and an archeological site, Fort Hancock, and the Sandy Hook Proving Grounds, all of which enhance and are enhanced by the handsome structure of the Highlands Bridge (NOTE: Sandy Hook, Twin Lights and Fort Hancock are National Landmarks); and

**WHEREAS**, the Highlands Bridge is depicted in several significant photographs and works of art; and

WHEREAS, the Highlands Bridge is a double leaf bascule draw bridge which is historically significant, is part of New Jersey's coastal h eritage and represents the character and ambiance of the area surrounding the bridge, including Highlands, Sea Bright, Rumson, Navesink, Monmouth Beach and Sandy Hook; and

**WHEREAS,** the Highlands Bridge is functioning in sound condition, has an exemplary safety record and can be repaired and maintained in its present form, likely for less money then it would cost to build a new bridge; and

WHEREAS, NJDOT has contended that traffic is an issue, but it is only an issue on the weekends during the summer months and replacement of the draw bridge will not correct this problem; and

**WHEREAS,** NJDOT has contended that the bridge has gotten stuck numerous times, but the borough has not interpreted this to be a serious issue; and

**WHEREAS**, the age and design of this functioning double leaf bascule bridge make it a significant historic structure worthy of preservation; and

**WHEREAS**, the information regarding the need for the destruction of the Highlands draw bridge that was provided to the public by the New Jersey Department of Transportation, has been called into question and is reportedly different from the information provided to the Government.

**NOW, THEREFORE, BE IT RESOLVED,** that the Mayor and Council of the Borough of Highlands hereby withdraw all support for the destruction of the Highlands to Sea Bright Draw Bridge and formally oppose the proposed construction of the fixed span bridge across the Shrewsbury River in place of the draw bridge;

**BE IT FURTHER RESOLVED,** that the Mayor and Council of the Borough of Highlands hereby direct and support the NJDOT to repair the historically significant double leaf bascule bridge over the Shrewsbury River, and to preserve this piece of New Jersey coastal heritage;

**BE IT FURTHER RESOLVED**, that the Mayor and Council of the Borough of Highlands hereby directs that the State and National Historic Preservation Agencies designate the Highlands Bridge as a Historic Structure and a Structure of Historical

Significance, the bridge does not have a nomination prepared – it does have a historical significance – it is eligible for the State and National Registers of Historical Places. Once it is in the New State Register, there is an additional process. The Mayor and Council of the Borough of Highlands recommend that the State or other appropriate agency pursue a nomination;

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Highlands hereby direct the Clerk to forward certified copies of this Resolution to Governor Jon Corzine, Senator Frank Lautenberg, Senator Robert Menendez, Congressman Frank Pallone, Congressman Rush Holt, State Senator Joseph Palaia, State Senator Joseph Kyrillos, Assemblyman Steven Coredemus, Assemblyman Sean Kean, Senator Ellen Karcher, Assemblyman Michael Panter, Assemblyman Jennifer Beck, the Commissioner of the Department of Transportation, The Commissioner of the Department of Environmental Protection, the Mayor and Council of Sea Bright, Rumson, Middletown, Atlantic Highlands, Monmouth Beach, Little Silver, Oceanport, Gateway National Recreation Area – Sandy Hook and the Monmouth County Board of Chosen Freeholders.

Seconded by Mr. Urbanski and adopted on the following roll call vote:

Mayor O'Neil thanked everyone for coming out and that he hoped The Honorary Title everyone would all stay together on this issue.
