#### **Ocean Tidal Power Generation Presentation:**

Roger Basin and his wife are the owners of Natural Currents Energy Services, LLC. He stated the company has been around for 10-years. He explained that the lateral movement of the tides is converted into electricity using a turbine. Here in New Jersey they have a great deal of support from the NJDOT and they have a grant from the State of New Jersey to install a turbine in Point Pleasant Beach. Also the State of New Jersey has requested that our company evaluate the twenty best sites in the State for tidal energy generation. So over the next 18-months we expect to identify these areas and identify the environmental impact, financial impact and the energy impact. He stated that one of the sites that they are looking at is here in Highlands and we have found that you have an excellent tidal resource and they have actually tested for tidal disturbance today. The property owner of the site in Highlands is here with him tonight as well as his wife. He then asked if there were any questions.

Mayor Little questioned financing of this.

Roger Basin – based on our work here which began in May of this year they have evaluated the waterway and submitted a proposal to the United States Department of Energy. They have proposed to test and install tidal turbines, which would be fifty percent supported by Department of Energy. Whether they fund it or not we expect to find private financing to install these. He

explained that you can generate power and sell it to utility companies. He also stated that the Borough has ten Riparian Grants.

Mr. Francy questioned the unit that would be installed at Mr. Colby's property on South Bay Ave.

Mr. Basin described the system that they tested at this site was a two by ten foot unit and they are looking to install a five by fifty foot unit.

Ms. Kane requested a pamphlet on this information.

Mrs. Basin explained that the turbine will not be visible, it will be submerged underwater.

**NOW, THERFORE BE IT ORDAINED** by the Governing Body of the Borough of Highlands that Chapter 6,Section 6.3 of the Revised General Ordinance of the Borough of Highlands be amended and supplemented in the following part:

#### 6-6.3 Identification Cards; One File; Expiration Date.

The Borough of Highlands Police Department shall furnish to the licensee and to every agent, bartender, waiter, waitress or other employee connected with or employed by the licensee and who will handle alcohol directly during course of discharging duties by licensee an identification card demonstrating compliance with the provisions of this section. This card shall be on file on the licensed premises and shall be exhibited upon demand at any time requested by any law enforcement office or official of the Borough of Highlands. Such identification card shall expire one year three years from the date of issue, at which time new photographs shall be taken by the Highlands Police Department and a new fee therefore paid by the licensee. Every licensee and every agent bartender, waiter, waitress or other employee connected or person associated or to be associated with or employed by licensee and who will handle alcohol directly during course of discharging duties by licensee in the future shall make application for liquor sale or distribution identification cards within ten days of employment or association with the license shall secure the identification card as provided for in this section.

**BE IT FURTHER ORDAINED** that all other provisions of Ordinance 6-6.3 which are not expressly amended herein shall remain in full force and effect, except to the extent modified hereby.

Mrs. Cummins read the title of Bond Ordinance O-10-14 for the second reading and public hearing. She stated that notice of this bond ordinance was published in the July 30<sup>th</sup> edition of the Two River Times.

Mayor Little opened up the public hearing on Bond Ordinance O-10-14.

Donald Manrodt of Bayside Drive question engineers cost estimate.

Robert Keady, P.E., Borough Engineer explained the engineering costs. He stated that this is a grant from the NJDOT and is for engineering design and utility investigation and this bond ordinance is for the front costs.

Mr. Manrodt stated that this is a high engineering price and we should bid it out.

Mr. Francy explained that this is a 1.12 million dollar project and this percentage of engineering costs of \$170,000 is an acceptable percentage for this.

Michelle Pezzullo of 115 Highland Avenue questioned how this bond ordinance would affect property taxes.

Mr. Pfeffer explained how this bond ordinance effects the budget.

Mayor Little further explained that there is grant money and she explained the grant money process.

Mr. Francy stated that the NJDOT grant does not cover the soft costs for design.

There were no further questions or comments from the public; therefore Mayor Little closed the public hearing on Bond Ordinance O-10-14.

Mrs. Cummins read the title of Bond Ordinance O-10-14 for the third and final reading and adoption.

Mr. O'Neil offered the following Bond Ordinance and moved on its adoption and authorized its publication according to law:

#### O-10-14

BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$170,000 FOR RECONSTRUCTION OF HIGHLAND AVENUE FOR AND BY THE BOROUGH OF HIGHLANDS IN THE COUNTY OF MONMOUTH, NEW JERSEY AND, AUTHORIZING THE ISSUANCE OF \$161,500 BONDS OR NOTES OF THE BOROUGH FOR FINANCING PART OF THE APPROPRIATION.

BE IT ORDAINED, BY THE BOROUGH COUNCIL OF THE BOROUGH OF HIGHLANDS, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

#### SECTION 1:

The improvements described in Section 3 of this bond ordinance (the "Improvements") are hereby authorized to be undertaken by the Borough of Highlands, New Jersey (the "Borough") as general improvements. For the said Improvements there is hereby appropriated the amount of \$170,000, such sum includes the sum of \$8,500 as the down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in one or more previously adopted budgets for down payments for capital improvement purposes.

#### **SECTION 2**:

In order to finance the cost of the Improvements, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$161,500 pursuant to the provisions of the Local Bond Law (the "Bonds"). In anticipation of the issuance of the Bonds and to temporarily finance said improvements or purposes, negotiable bond anticipation notes of the Borough are hereby authorized to be issued in the principal amount not exceeding \$161,500 pursuant to the provisions of the Local Bond Law (the "Bond Anticipation Notes" or "Notes").

#### **SECTION 3:**

(a) The Improvements authorized and the purpose for which obligations are to be issued, the estimated cost of each Improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each Improvement and the period of usefulness of each Improvement are as follows:

- (b) The estimated maximum amount of Bonds or Notes to be issued for the purpose of financing a portion of the cost of the Improvements is \$161,500.
- (c) The estimated cost of the Improvements is \$170,000 which amount represents the initial appropriation made by the Borough. The excess of the appropriations made for the Improvements and the estimated maximum amount of Bonds or Notes authorized to be issued therefor as stated above is the amount of the Down Payment.

#### SECTION 4:

All Bond Anticipation Notes issued hereunder shall mature at such times as may be determined by the chief financial officer of the Borough (the "Chief Financial Officer"); provided that no Note shall mature later than one year from its date. The Notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with Notes issued pursuant to this ordinance, and the signature of the Chief Financial Officer upon the Notes shall be conclusive evidence as to all such determinations. All Notes issued hereunder may be renewed from time to time subject to the provisions of Section 8(a) of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the Notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Borough Council of the Borough at the meeting next succeeding the date when any sale or delivery of the Notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the Notes sold, the price obtained and the name of the purchaser.

#### SECTION 5:

The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey is on file with the Borough Clerk and is available for public inspection.

#### SECTION 6:

The following additional matters are hereby determined, declared, recited and stated:

- (a) The Improvements described in Section 3 of this bond ordinance are not current expenses, and are capital improvements or properties that the Borough may lawfully make or acquire as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The period of usefulness of the Improvements, within the limitations of the Local Bond Law, and according to the reasonable life thereof computed from the date of the Bonds authorized by this bond ordinance, is 20 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Borough Clerk and a complete executed duplicate thereof has been filed in the office of the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey. Such statement shows that the gross debt of the Borough, as defined in the Local Bond Law, is increased by the authorization of the Bonds and Notes provided in this bond ordinance by \$161,500 and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.
- (d) An aggregate amount not exceeding \$170,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost of the Improvements, as indicated herein.

#### SECTION 7:

Any funds received from time to time by the Borough as contributions in aid of financing the purposes described in Section 3 of this Ordinance shall be used for financing said Improvements by application thereof either to direct payment of the cost of said Improvements or to the payment or reduction of the authorization of the obligations of the Borough authorized therefor by this Bond Ordinance. Any such funds received may, and all such funds so received which are not required for direct payment of the cost of said Improvements shall, be held and applied by the Borough as funds applicable only to the payment of obligations of the Borough authorized by this Bond Ordinance.

#### SECTION 8:

The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all the taxable property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

#### SECTION 9:

This Bond Ordinance constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The Borough reasonably expects to pay expenditures with respect to the Improvements prior to the date that Borough incurs debt obligations under this Bond Ordinance. The Borough reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the Borough under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$161,500.

#### SECTION 10:

This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Mayor Little explained that the BHI inspections will now happen annually instead of once every five years by the State. This ordinance addresses the fees that will be charged to the property owner for said inspections.

Carol Bucco – does that include condos.

Council explained that it would apply to condos with common areas.

Carol Bucco expressed her opposition to the proposed ordinance increasing the inspection fees.

Don Manrodt of 268 Bayside Drive questioned if this would eliminate the State inspections.

Mayor Little - yes it will.

Michelle Pezzulo of Highland Avenue asked what BHI meant.

Mayor Little replied that its Building and Housing Inspections.

Carol Bucco objected to the adoption of this ordinance.

There were no further questions or comments from the public; therefore Mayor Little closed the public hearing on Ordinance O-10-15.

#### **Finance**

Mr. Pfeffer spoke about the sewer utility budget and stated that with regard to the budget, there is no increase. With regard to the change in billing, we will go with it one more time and if the collection rate does not increase then we may go back to quarterly billing.

Mayor Little questioned electronic payments.

Mr. Pfeffer stated that he will speak with Tax Collector. He then spoke about the need to increase the sewer rate to \$480.00 yearly retroactive to cover the Atlantic Highlands/Highlands Regional Sewerage Authority costs.

Mr. O'Neil – our flow has gone up.

Mr. Pfeffer – we need to act quickly because rate is going to have to be retroactive.

Mr. O'Neil spoke about rainfall and the increase in infiltration.

The Council further discussed sewer budget.

#### **SFY 2011 Municipal Budget Discussions**

Mr. Pfeffer explained that he and Mr. Francy have been going back and forth with emails and we put together a lot of different scenarios and a lot of different spread sheets on trying to see where there was money to be saved by privatization, consolidation and retirements. We need a special meeting to discuss the possible budget cuts. That's why a special meeting for Monday August 23<sup>rd</sup> was mentioned.

Mr. Francy stated that he would get the spread sheets to the Borough Clerk to distribute to the Council. He will also email them to the Council Members.

Mr. Pfeffer spoke of wage freezes for all employees, freeze on health benefits, merge dispatch, reduce Police Dept by three officers, privatize residential garbage collection and contract out of house for mechanic services. He explained that after the Council goes into Executive Session then any action you need to take are taken after words in the public portion. So the regular meeting will start at 7:30 p.m. and then you go into Executive Session, then you go to public meeting.

Mr. Arnette advised the Council that this special meeting will be advertised for a public meeting and those issues that are okay to discuss in Executive Session, will be and those that are not will not be

Mr. Nolan offered a motion to have a Special Council Meeting on August 23<sup>rd at 7:30</sup> p.m. to discuss SFY 2011 Budget Cuts, seconded by Mr. Francy and approved on the following roll call vote:

#### **DPW Report**

Mr. Hilling stated that bulk pick up is scheduled for September by zone along with Brush pick up. We are still waiting for FEMA to come through on the money for the Waterwitch Avenue Pump Station. A new chain link fence was installed at the old sewer plant and we have signs there prohibiting parking.

#### **Public Safety**

Chief Blewett read through the following report:

Report to Council August 2010

- \* As per the question raised by Carla Braswell at the last Council meeting, as per Borough Ordinance 6-6.1 the fee for the issuance for an identification card is \$20.00. The Highlands Police Department has been charging \$5.00 for a duplicate card.
- \* As per the questions raised by Councilman Francy in response to handicap signs, the Highlands Police Department makes a recommendation to the Governing Body for the issuance of a handicap parking sign only after the State has issued the said person a permanent handicap placard or license plates. The Borough of Highlands does not have an ordinance in reference to this but it's governed by Title 39:4-197.5 & 39:4-197.6. As per the NJ Motor Vehicle Commission handicap plates are renewed every year and a permanent placard has to be renewed every three years. After the initial application the State does not require the applicant to obtain certification from a physician that he or she is disabled. He then asked if we could enact an ordinance to make applicants renew their plaque.

#### Mr. Francy - we can talk about this later.

- \* On August 7, 2010 duty officers responded to a report of an aggravated assault. The investigation revealed that two individuals where assaulted by William Gill. During the investigation officers responded to Gill's Washington Avenue residence where they arrested William Gill, age 21, for aggravated assault, criminal restraint and terroristic threats. Gill allegedly assaulted the two victims while they were at his residence. After the assault both victims left the residence, sometime thereafter victim #2 was approached by Gill and forcibly taken back to his residence where the victim was threatened and detained against his will.
- \* Between August 1 and August 2, 2010, the Highlands Police Department investigated two separate vehicle burglaries in the Second Street area. An unknown actor gained entry to one vehicle removing several items but was confronted by the vehicle owner prior to gaining entry into the second vehicle and fled the scene. After a brief investigation a 17 year old Highlands resident was charged with these burglaries, as well as, confessing to at least a dozen more. This is the third individual in the last three months charged with multiple vehicle burglaries. All three suspects targeted unlocked vehicles, therefore, the Highlands Police Department urges residents remove any valuables including GPS units and to lock their vehicles. As always, all residents are urged to report any suspicious activity to the department at (732) 872-1158.

Summer Kidfest 2010 (July 1 to August 13.) For July - 130 children enrolled. Nutrition component is serving over 150 meals per day (breakfast and lunch). Activities and events for July included: Hot Shot Contest, Pool Tournament, Home Run Derby, Arts and Crafts, Frisbee Golf, Volleyball, Pitch Hit and Run event, Hula Hoop Contest, Street Hockey, Table Soccer Tournament, Scavenger Hunt, "Gertrude Ederle Water Relay Day".

#### Beach:

- 1. Weekly Coastal Monitoring Reports have been excellent (June through July). All concentrated bacteria (enterococci) levels for this period were well below the 104 pp 100 mL. Areas tested continue to be the beach off of Connor's, Snug Harbor, and Miller Street.
- 2. Weekday Ave. at Snug Harbor for July = 41 (inclusive of Summer Rec.visits) Weekends = 70+ Weekday Ave. at Miller St. for July = 22, Weekends = 37.
- 3. Additional Lifeguards have been hired to cover schedule as needed.

The following is the status of various projects in which we are involved as Borough Engineer:

#### General

1. Valley Avenue Drainage Repairs: We have been authorized by the Governing Body to proceed with design of this project. The project design has been completed and approved by the NJDOT. The project was advertised for bidding and bids were received on July 9, 2009. Two bids were received and both costs were above the Engineer's Estimate and were formally rejected by Mayor and Council on July 15, 2009. As a result, the Bond Ordinance was amended to increase the overall amount.

Bid Date: October 14, 2009

Contractor: En-Tech Corporation, Closter, NJ

Amount: \$96,125.00

The Borough awarded the project to En-Tech in this amount at the October 22, 2009 Council Meeting. Contracts have been processed and a pre-construction meeting was held on December 10, 2009. The project has been completed. The contractor has submitted a post-lining video for review. T&M Associates reviewed the video and found the lining to be satisfactory. The NJDOT has declined to perform a final project walkthrough. All remaining concerns have been addressed to the satisfaction of this office. The final project close out documentation has been completed and will be transmitted to the Borough for final payment.

2. **Sanitary Sewer Flow Metering – Monmouth Hills:** As requested by the Borough, we have solicited a quotation to monitor the sanitary sewer flow from Monmouth Hills that is collected within the Borough's sanitary sewer system. We have identified three (3) locations at which the meters will be installed. We are currently preparing a proposal to interpret the data and prepare a summary report outlining the metering results.

#### **Capital Improvement Projects**

- 1. **Basin Two Sanitary Sewer Rehabilitation Project:** T&M Associates has prepared a design to implement the recommended improvements outlined in the initial investigation report. The design of this project is complete and has been sent to the Borough for signature and authorization to bid. This project is on hold due to funding. As requested by Mayor and Council we prepared and submitted a Federal Appropriations grant application to Senators Lautenberg and Menendez to request assistance with funding of this project. On March 18, 2010, T&M submitted additional documentation per the request of Senator Lautenberg's office. The documentation was sent to both Senator Lautenberg and Menendez as required.
- 2. **Permanent Electrical Services to Accommodate Emergency Generators Project:** We have completed the design of the project and obtained County approval to bid the project.

Bid Date: May 13, 2010

Contractor: Gary Kubiak and Son Electric, Inc., Allentown, NJ

Amount: \$49,307.00

The project was awarded to Gary Kubiak and Son Electric, Inc. on May 19, 2010. A preconstruction meeting was held on June 10, 2010 at Borough Hall. All shop drawings have been reviewed and approved. The Contractor has mobilized and will at a minimum, be completed with the Community Development funded portion of the Contract by August 13, 2010. To satisfy County funding requirements, the Contractor must be paid in full (funded portion only) by August 25, 2010.

- 3. **Flood Reduction Program:** A project presentation was made to the Mayor and Council at the March 17, 2010 Council meeting outlining various project options. T&M Associates has provided revised various project cost options to the Borough CFO and discussed. T&M Associates is currently awaiting further direction from Mayor and Council prior to advancing the project beyond the design of the Snug Harbor pumpstation, which is progressing along with the Bay Avenue stormwater crossing at Jones Creek. A project status meeting was held on July 20, 2010 with Borough representatives. T&M Associates also provided a status update and rendering of the proposed Snug Harbor Pumpstation at the July 21, 2010 Council meeting. A project financial meeting was held with Borough representatives on August 4, 2010 to discuss project phasing and possible grant sources. T&M Associates is currently awaiting direction with regards to advancing the overall design of the project.
- 4. The Resurfacing of Waterwitch Avenue: The Borough received funding for this project in the amount of \$192,000.00. On March 27, 2009, we notified the NJDOT in writing that the Borough is requesting to reduce the limits of this project to the area between N.J.S.H. Route 36 and Linden Avenue and are currently preparing the NJDOT requested paperwork. At the May 20, 2009 meeting, Mayor and Council requested that the sanitary sewer improvements be added into the request. The paperwork was submitted to the NJDOT on June 19, 2009 for consideration. On July 16, 2009, the NJDOT sent a letter to our office stating that they approve the request to reduce the project limits. The Borough authorized T&M Associates to design and inspect the project on December 16, 2009. The Borough has adopted a Bond Ordinance to cover costs above the NJDOT award amount. The design of the project has been completed. The project was advertised for bidding on July 21, 2010 and bids were received on August 3, 2010.

Bid Date: August 3, 2010

Contractor: Fiore Paving Company, Inc., Oceanport, NJ

Amount: \$163,637.50

The project was awarded to Fiore Paving Company, Inc. on August 9, 2010 for the above amount. Contracts are currently being prepared and the required documentation has been forwarded to the NJDOT for their concurrence with the contract award.

- 5. **2010 Roadway Improvements Project:** T&M Associates has prepared and submitted an overall proposal for design and contract administration services for the following roadways:
  - Highland Avenue Reconstruction: from Portland Road to Valley Avenue

- Valley Avenue Reconstruction: from Route 36 to the western terminus
- Miller Street Reconstruction: from Route 36 to Highland Avenue
- Woodland Street Reconstruction: from Highland Avenue to Prospect Street
- Prospect Street Mill/Overlay: from Osborne Street to a limit east of Woodland Street
- Bay View Street Rehabilitation: The entire length

The proposal provided a breakdown of each roadway so that the Borough has the option to only proceed with various portions of the overall project if they choose to do so. It should be noted that the NJDOT awarded the Borough \$1,184,000.00 in Discretionary Aid for Highland Avenue and the portions of Valley Avenue and Miller Street between Route 36 and Highland Avenue. T&M Associates and representatives from the Borough Council held a pre-design walkthrough with the residents on Highland Avenue on May 8, 2010. All comments will be reviewed and incorporated into the design as appropriate. Further discussions with the Borough have resulted in a possible change in the approach to Valley Avenue from Highland Avenue to the western terminus. We are currently investigating revising the rehabilitation of this roadway from a reconstruction to a mill/overlay project. Once, determined, we will update the overall cost estimate and revise our proposal accordingly. The Borough has introduced a bond ordinance to cover all design and investigative costs associated with Highland Avenue.

#### **Grants and Loans**

- 1. **FY 2010 NJDOT Municipal Aid Bay Avenue:** The Borough was has been notified that they have been awarded \$250,000.00 for the reconstruction of Bay Avenue between Waterwitch Avenue and Gravelly Point. This project will also include drainage improvements along Bay Avenue in the vicinity of Jones Creek. A meeting should be held between T&M Associates and Borough Officials to discuss project approach (phasing, etc.). A construction contract must be awarded by August 16, 2011 to avoid jeopardizing the allotted funding.
- 2. FY 2011 Monmouth County CDBG Application: As requested by the Borough, T&M Associates prepared and submitted a CDBG application to Monmouth County for consideration on the Borough's behalf. The application is for The Reconstruction of Bay Avenue Phase II. T&M Associates will present the project to the County CD Committee on August 18, 2010. We are currently preparing the presentation to submit to the County for review and approval.
- 3. **Alternative Energy:** At the April 7, 2010 Councilmeeting, T&M Associates gave a presentation to the Mayor and Council pertaining to the utilization of alternate energy. The presentation focused specifically on funding and procedures. T&M Associates has forward additional information to the governing body for their review.
- 4. **FY 2011 NJDOT Municipal Aid The Reconstruction of Woodland Street:** As requested by the Borough, T&M Associates is currently preparing a Local Aid grant application for the above project to the NJDOT for consideration. The application is due electronically to the NJDOT August 13, 2010.

Mr. Francy stated that at the last meeting they spoke about a referendum for the flood capital project. Dave Parker will work with T & M for six months to see if we can get more grants so the need for a referendum is withdrawn.

Mayor Little advised the Borough Engineer to not stop working on permits and the design should be moving forward on the funded phases

Mr. Francy also stated that the engineer should be moving forward with the design and permits for the funded phases.

Mr. Keady explained that in order to continue with the I.E.T. Trust Program we need a commitment letter. He then asked for authorization to send a commitment letter out.

Council had no objection to sending out a commitment letter.

#### **Review of OPRA Fees**

Mrs. Cummins explained that we received a notice from the Government Records Council which indicated that the fees for copies can only cover the cost of the paper and toner; therefore we are required to reduce our fee.

Council authorized an ordinance to be introduced at the next meeting.

#### **Review of Disorderly Conduct Ordinance**

Mr. Arnette stated that we received a letter from the New Jersey Libertarian Party and he will look at this and if need be he will report back to the Borough Clerk if any action is required.

#### Review of Rauen Letter dated August 2, 2010 RE: S. Pad Performance Bonds

Margaret Rauen was present.

Mr. Arnette explained that whatever money is available which he believes is less than \$2,500 would be accessed only to the homeowners association and they would have to request it. This money is only for site improvements it wouldn't necessarily go to the improvements that Mrs. Rauen requested.

Mr. Pfeffer stated that there is approximately \$2,500 left in that account.

Mr. Arnette stated we must be contacted by appropriate parties.

Margie Rauen questioned if the \$36,000 bond was ever refunded.

Mr. Pfeffer explained research process for these funds.

Mayor Little informed Mrs. Rauen that he Condo Association needs to come in and request the balance.

#### **School Speed Limit Flashing Sign**

Chief Blewett explained that he had requested that NJDOT install school speed limit flashing sign and we received a quote from the DOT \$81,000 and we only have to pay 25%.

Council did not authorize this due to cost. They directed the Borough Clerk to send a letter of no interest to the NJDOT.

#### Review Website Spec & Authorize Purchasing Agent to Advertise for RFP'S

Mr. Francy stated that the Website Committee has completed a draft Request for Proposal for Website Design and Development. The Committee is asking for authorization for the Purchasing Agent to send this out for RFP's. Once RFP's are received they can be reviewed by the Committee and the Purchasing Agent. They will bring the top three proposal back to the Council and then we can take it from there.

Mr. Nolan offered a motion to authorize the Purchasing Agent to advertise for RFP's, seconded by Mr. Francy and approved on the following roll call vote:

Mayor Little – we already discussed this under the Finance Report but she would like to mention that there is a Property Revaluation Order for the Borough of Highlands.

Mrs. Cummins stated that the Council did adopt a Resolution this evening authorizing the Tax Assessor to obtain price quotes for a revaluation.

#### **Community Incite**

Mrs. Kane stated that there is a consulting group that we can hire and what they do is find your shortcomings in the local Commerce and that kind of stuff. They advise you on what's going on and we have hit an impasse where everything was such a scurry with the HBP. So we don't have a plan and she feels we should look into this.

Mayor Little – we can have them give us a presentation and we should inform the HBP.

The Borough Clerk was directed to set up a presentation and to inform the HBP.

#### <u>Laura's Pancake House – Request for Approval of Customer Appreciation Day</u>

Mrs. Cummins stated that Laura's Pancake House is looking to have a DJ on private property. The Chief of Police was concerned that there could be a possible noise ordinance violation. So he wanted the Council to approve this.

There was no objection from the Council.

#### **Impact Fees**

Ms. Kane stated that she and Mr. Nolan have been speaking about this and basically what we are looking for is to have the Borough Attorney speak to the Planning Board Attorney to see what we can do and then give them our recommendations.

Mayor Little – I think that there is a need to hear back from the Planning Board Attorney on a certain particular application.

Mr. Nolan – we were thinking about a general dollar amount overall moving forward and then obviously case by case. We wanted the Borough Attorney to start the conversation.

Mr. Arnette – I can contact the Planning Board Attorney.

Mr. Francy – there is an emergent problem and this problem got started with Dave Parker, Fire Official. The issue is at this point it would appear that according to an opinion rendered by the Planning Board Attorney that the Developers Agreement as applied to this particular application has to be in place at the time of the Resolution.

Mr. Arnette – I will speak with the Planning Board Attorney tomorrow.

Mayor Little – I think that the Developers Agreement comes later after the Resolution.

Mrs. Cummins stated that one of the conditions of the Planning Board Resolution will be that a Developers Agreement is required.

Mayor Little – we spoke about this in Executive Session and we will speak again to make a final decision.

Maria Schaffer stated that she wants a copy of the report on this property.

Mayor Little stated that the goal of the borough is to wrap this up at the September 1<sup>st</sup> meeting.

Don Manrodt of 268 Bayside Drive spoke about Exxon that they have been taking samples on Bayside Drive, they want to get onto the Mobile Home Property. He then stated that he wants the Borough to verify the number of units that we are billing Monmouth Hills for sewer.

Bernadine Harford of Highland Avenue commented on the weight limitation on Highland Avenue. Trucks are exceeded weight and damaging the street and cars are exceeding speed limits. She suggested that it be a one-way on Valley Ave off of the Highway.

Chief Blewett stated that this was previously recommended and it was turned down.

Mr. O'Neil spoke about problems that would be created by making Valley a one-way.

Michelle Pezzullo of 115 Highland Avenue stated that Mr. O'Neil does not live on Highland Avenue so he does not know how fast the cars drive there. She then stated that she has an issue with the house next to the school, they have a barking dog.

Chief Blewett advised her to call the police regarding the dog barking.

Michelle Pezzullo stated that she smelled gas on Highland Avenue and that the Gas Company could not find it, which she further explained and discussed with the Council. She stated that he storm drains are clogged up.

Mr. Hilling will send Reg Robertson, DPW Supervisor up to check it out.

Jim Parla of 16 Portland Road questioned combined meeting with Atlantic Highlands.

Mayor Little explained that it was a closed session meeting.

Carol Bucco of 330 Shore Drive spoke about traffic from Valley Ave to the bridge being worst part of highway, which she further discussed with the Council.

There were no further comments from the public.

Mr. O'Neil offered a motion to adjourn the meeting, seconded by Mr. Nolan and all were in
