O-13- 7 BOROUGH OF HIGHLANDS COUNTY OF MONMOUTH

ORDINANCE AMENDING SECTION 3-2.3, "ENUMERATION OF NOISES" TO PERMIT THE PLAYING OF OUTDOOR MUSIC UNTIL 10:00 P.M. ON SUNDAYS BETWEEN MEMORIAL DAY WEEKEND AND LABOR DAY AND TO PERMIT THE PLAYING OF OUTDOOR MUSIC UNTIL 11:00 P.M. ON SUNDAY, MAY 26, 2013

WHEREAS, the Borough of Highlands regulates the emanation of noise by and through Section 3-2, "Noise" of the Code of the Borough of Highlands; and

WHEREAS, the Borough wishes to amend Section 3-2.3, "Enumeration of Noises" to permit the playing of outdoor music, either live or recorded until 10:00 p.m. on Sundays between Memorial Day weekend and Labor Day; and

WHEREAS, due to the anticipated increased tourism resulting from the first opening of the Summer season after the effects of Hurricane Sandy, the Borough wishes permit the playing of outdoor music, either live or recorded until 11:00 p.m. on Sunday, May 26, 2013; and

WHEREAS, the Borough finds that it is in its best interests to amend Section 3-2.3 of the Code of the Borough of Highlands to permit to permit the playing of outdoor music until 10:00 p.m. on Sundays between Memorial Day weekend and Labor Day and to permit the playing of outdoor music until 11:00 p.m. on Sunday, May 26, 2013; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Highlands, County of Monmouth, State of New Jersey, as follows:

SECTION ONE. Borough Code Section 3-2.3(b), "Enumeration of Noises" shall be amended to provide as follows:

- (b)(1)The playing of music outdoors, either live or recorded, between the hours of 8:00 p.m. and the following 8:00 a.m. on Sunday, Monday, Tuesday, Wednesday, Thursday, and between the hours of 10:00 p.m. and the following 8:00 a.m. on Friday and Saturday is hereby prohibited;
- (2) Between and including the Sunday before Memorial Day and Labor Day, the playing of music outdoors, either live or recorded, between the hours of 8:00 p.m. and the following 8:00 a.m. on Monday, Tuesday, Wednesday, Thursday, and between the hours of 10:00 p.m. and the following 8:00 a.m. on Friday, Saturday and Sunday is hereby prohibited;
- (3) On Sunday, May 26, 2013, the restriction provided by subparagraph (b)(2) above shall read "the playing of music outdoors, either live or recorded, between the hours of 11:00 p.m. and the following 8:00 a.m. on Friday, Saturday and Sunday is hereby prohibited;"

SECTION TWO. Severability. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION THREE. Repealer. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION FOUR. Effective. This Ordinance shall take effect after final passage as provided by law.

North Street Pump Station:

Mr. Francy looked at the pump plans and feels they are problematic. He would like Mr. Leubner to revise the plans below base level of 6 ft., size of pumps, and control that is submersible.

Mr.Leubner commented. We can remove a pump if council wants. We have to make it FEMA compliant or we will not be eligible for FEMA funding.

Ms. Ryan would like to see it smaller.

Mayor Nolan asked Mr. Leubner to see if he can get it on a smaller scale.

Public Portion:

Don Manrodt of 268 Bayside Drive spoke of the old pipe on North Street and Bayside Drive project.

Mr. Leubner explained the design on the Bayside Drive project.

Mr. Mandrodt asked if Exxon is going to remove the wall.

Discussion continued on the Bayside Drive project.

Arnie Fuog of Valley Street spoke about a tool lending library.

Mr. Hill stated that we may not be allowed to get involved in that for insurance purposes.

Mr. Fuog said other towns have done this and will give the information to Mr. Hill for distribution to the council.

Maureen Welch of 50 Valley Avenue said she was told at that distribution center that there would be a tool lending library.

Mr. Hill said we need a non-profit organization to take this on.

Mr. Fuog asked HBP to sponsor.

Carla Braswell requested Mr. Fuog to send the information to her via email.

Mr. Fuog also has a letter of issues about the solution center.

Mr. Fuog was directed to email his letter to Mrs. Cummins. She will forward it to the council.

Rafella Lee questioned the fence at Ederly Park.

Mr. Hill said the fence will be moved back to borough property.

Carla Braswell stated that there is graffiti on handrails, signs on the bridge and the bus stop.

Mr. Hill mentioned volunteers to help clean up.

Dody Bauer of 9 South Peak Street said there isn't any running water at any of the parks. She also wants electrical repairs at Veteran's Park.

Mr. Hill said the electrical panel at Veteran's Park need to be replaced. It cannot be done quickly. The sprinklers can be run manually.

Dody Bauer said they need a water source.

Mr. Hill will look into a water source for the Garden Club.

Dody Bauer said they are applying for a clean community grant.

John Macaleer of 52 Barberie Avenue asked if we challenge the V Zone rating, will it prevent ICC funds.

Mr. Leubner responded that by adopting, it would not. He explained FEMA requirements.

John Macaleer continued to question challenge process. He also spoke of his insurance premiums.

Mr. Leubner explained.

John Macaleer questioned the rating system and why we are not in it.

Mr. Leubner stated that he personally applied with Mr. Hill. FEMA is coming to town to do an audit. They will determine if we are in.

Lori Dibble of 32 Paradise Park questioned the wording of Ordinance O-13-8. She said that people are not able to get in to homes at the trailer park. She further explained. The Mobile Unit Owners are not getting any assistance. She wants the town to look into actions being taken by the landowner Mr. Bollerman.

Chief Blewett said she is not following the proper channels.
There were no further questions.
Mayor Nolan offered a motion to adjourn, seconded by Ms. Kane and all were in favor.
