## Status of Highlands Landing Corp (Seastreak) Approval

Mr. Serpico explained to the board that this applicant received final site plan approval in January 2001, giving them two years of frozen rights in terms of any zoning changes. There after they applied for three one-year extensions which expired in January of 2006. The misconception is that their site plan approval has expired which is not the case. The only thing that has expired is the protection against any zoning changes. So at this point in time if the borough were to change their development ordinance that would have an effect on this project then they would have to comply with the new ordinance or go to the appropriate board for the appropriate approvals. Resolution Compliance is different from expiration of site plan approval which he further described that if Resolution Compliance hasn't been completed then they really can't build what they received approval to build until they do Resolution Compliance.
